GENERAL PROVISIONS

§ 70.01 STATE TRAFFIC LAWS ADOPTED.

Except as otherwise specifically provided in this chapter, the statutory provision in Wis. Stats. Chs. 340 to 348, describing and defining regulations with respect to vehicles and traffic, exclusive of any provisions therein relating to penalties to be imposed and exclusive of any regulations for which the statutory penalty is a fine or term of imprisonment, are adopted and by reference made a part of this chapter as if fully set forth herein. Any act required to be performed or prohibited by any statute incorporated herein by reference is required or prohibited by this chapter. Any future amendments, revisions or modifications of the statutes incorporated herein are intended to be made part of this chapter in order to secure uniform statewide regulation of traffic on the highways, streets and alleys of the state. TRAFFIC REGULATIONS

§ 70.15 ONE-WAY TRAFFIC.

One-way traffic shall be as designated in Chapter 73, Schedule I.

§ 70.16 HEAVY TRAFFIC PROHIBITED.

No person shall operate any motor vehicle having a gross rate of 10 tons or over on Doty Street from Commerce Street to U.S. Highway 151 within the city.

§ 70.17 STOP SIGNS.

Official stop signs shall be placed at the intersections designated in Chapter 73, Schedule II.

§ 70.18 PARKING LOT ACCESS.

No trailer, as defined in Wis. Stats. § 340.01(71), shall be permitted on or in the municipal parking lot located north of Old Darlington Road and east of Commerce Street. No loading or unloading of snowmobiles, all-terrain vehicles, motorcycles, or nonlicensed motorized vehicles, as defined in § 72.030, shall be permitted on or in the parking lot.

§ 70.19 NEIGHBORHOOD ELECTRIC VEHICLES

(A) Neighborhood Electric Vehicle defined. “Neighborhood electric vehicle” means a motor vehicle that is propelled by electric power and that conforms to the definition and requirements for low-speed vehicles as adopted in the federal motor vehicle safety standards for low-speed vehicles under 49 CFR 571.3(b) and 571.500. “Neighborhood electric vehicle” does not include a golf cart.

(B) Use Regulated. Subject to the provisions of this chapter, neighborhood electric vehicles may be operated on City streets having a posted speed limit of 35 m.p.h. or less. Neighborhood electric vehicles shall be operated only by those persons duly licensed to operate such vehicles by

the State of Wisconsin as required by applicable state statutes and regulations. Any neighborhood electric vehicle operated within the City shall be duly registered with and titled by the State of Wisconsin as required by applicable state statutes and regulations.

(C) Operation. The operation of a neighborhood electric vehicle as permitted by this chapter shall in all respects be in compliance with all state and local traffic laws, including but not limited to Chapter 70 of the Mineral Point Code, and owners and operators of neighborhood electric vehicles shall be subject to citations and forfeitures for any violation.

(D) Crossing a State Trunk Highway. Neighborhood electric vehicles may cross state trunk highway 39 at the following location(s): Ross Street, Doty Street, and Washington Street. Neighborhood electric vehicles may cross state trunk highway 23 at the following location(s): Commerce Street, Doty Street, and Shake Rag Street.

§ 70.20 ATVS AND NON-LICENSED UTILITY VEHICLES FOR WORK RELATED PURPOSES.

(A) General Prohibitions. No person may operate a non-licensed utility vehicle or an all-terrain vehicle on any street, alley, parking lot or other public lands or private lands or private parking lots held open to the public, for work related purposes, except as provided in this section.

(B) Permit Required. Notwithstanding Section (A), the owner of a non-licensed utility vehicle or all-terrain vehicle may apply to the City Clerk Treasurer for a permit to operate the vehicle for work related purposes. The fee for such permit shall be \$10.00 per vehicle, and is renewable on an annual calendar basis.

(C) Purposes. Permits may be granted for work related purposes only. "Work related purposes" shall include, but not be limited to, snow plowing and transporting lawn maintenance equipment to or from a job site. Work related purposes specifically exclude personal transportation and any and all recreational purposes.

(D) Operator to be Age Sixteen or Over. No person who has not attained the age of sixteen years may operate a non-licensed utility vehicle or all-terrain vehicle under the provisions of this section.

(E) Compliance with Rules of the Road. An operator of a non-licensed utility vehicle or an all-terrain vehicle shall observe and be subject to all regulations that are imposed upon other vehicles to the extent that such regulations are applicable and are not in conflict with this section.\

(F) Speed. Non-licensed utility vehicles and all-terrain vehicles operated within the City of Mineral Point under this section shall not exceed a speed of 25 miles per hour.

(G) Penalty. Any person who violates any provisions of this section shall be subject to a forfeiture of \$25, plus costs and fees. Any person who violates any provision of this section for a second time within a twelve month period will not be eligible for renewal of the permit for the vehicle for a twelve month period.

ENFORCEMENT

§ 70.30 PROCEDURE.

This chapter shall be enforced according to Wis. Stats. §§ 66.0215, 345.20 to 345.53 and Ch. 799. (1989 Code, § 7.11) (Ord. 327, passed - -)

§ 70.31 DEPOSIT.

(A) Any person arrested for a violation of this chapter may make a deposit of money as directed by the arresting officer at the police station or at the office of the Clerk of Court or by mailing the deposit to those places.

(B) The arresting officer or the person receiving the deposit shall comply with Wis. Stats. § 343.27 or, if the deposit is mailed, the signed statement required under Wis. Stats. § 343.27 shall be mailed with the deposit. The arresting officer or the person receiving the deposit shall notify the arrested person, orally or in writing, that:

(1) If he or she fails to appear in court at the time fixed in the citation, he or she will be deemed to have tendered a plea of no contest and submitted to a forfeiture plus costs not to exceed the amount of the deposit; or

(2) If he or she fails to appear in court at the time fixed in the citation, and if the court does not accept the deposit as a forfeiture, he or she will be summoned into court to answer the complaint.

(a) The amount of the deposit shall be determined in accordance with the deposit schedule established by the Board of County Judges. The deposit shall include court costs and suit tax.

(b) The arresting officer or the person receiving the deposit shall issue the arrested person a receipt therefor as required by Wis. Stats. § 345.26(3)(b).

(3) If a deposit schedule has not been established, the arresting officer shall require the alleged offender to deposit not less than the maximum forfeiture permitted under this chapter.

§ 70.32 STIPULATION OF NO CONTEST.

Any person charged with a violation of this title, except Wis. Stats. §§ 346.62 and 346.63(1) may make a stipulation of no contest pursuant to Wis. Stats. § 345.27, which must be received at the office of the Police Department or Clerk of Court within 10 days of the date of the alleged violation. The person shall, at the time of entering into the stipulation, make the deposit required under § 70.31, if he or she has not already done so. A person who has mailed or filed a stipulation under this section may, however, appear in court on the appearance date and may be relieved from the stipulation for cause shown as required in Wis. Stats. § 345.37.

§ 70.99 PENALTY.

The penalty for violation of any provision of this title shall be a forfeiture as hereafter provided together with costs under Wis. Stats. § 345.27.

(A) *State forfeiture statutes.* Forfeitures for violation of Wis. Stats. Chs. 340 to 348 shall conform to the forfeiture permitted to be imposed for violation of the statutes adopted by reference, including any variations or increases for subsequent offenses.

(B) *State fine statutes.* The forfeiture for violation of any statute adopted by reference hereunder for which the penalty is a fine shall not exceed the maximum fine permitted under that statute.

(C) *Local regulations.* Except as otherwise provided in this chapter, the penalty for violation of §§ 70.16, 70.17, Ch. 71, and §§ 72.015 through 72.020 shall be as provided in § 10.99 of this municipal code.

GENERAL REGULATIONS

§ 71.01 PARKING DURING FIRES.

No person shall drive into or park on any block where fire apparatus is being used in response to a fire alarm. No person shall park any vehicle within 50 feet of a hydrant being used by the Department in response to a fire alarm. This section shall apply to private vehicles being operated by members of the Fire Department.

§ 71.02 STREET STORAGE PROHIBITED.

No motor vehicle, trailer, mobile home or camper shall be parked on any street for more than 24 hours.

§ 71.03 24-HOUR PARKING.

(A) No motor vehicle, tractor or trailer shall be parked on any street or parking lot within the city continuously in the same position for more than 24 hours at any 1 time, except that such vehicles may be parked on parking lots in stalls which are not usually used by the general public for short-time parking.

(B) Any owner or operator who shall park any motor vehicle, tractor or trailer upon any street or parking lot in the city shall remove the vehicle upon receiving 3 hours' notice to remove the vehicle by the Police Department or Street Department to permit proper removal of snow.

§ 71.04 ALTERNATE SIDE PARKING.

(A) Pursuant to Wis. Stats. § 349.13, no person shall park any vehicle between 12:01 a.m. and 6:00 a.m. from November 15 to April 1, except on the even-numbered side of each street on even-numbered days and on the odd-numbered side of each street on odd-numbered days.

(B) The designated streets as set forth in Chapter 74, Schedule V shall not be subject to the alternate side parking rules and shall be governed by the 24-hour parking regulations in § 71.03 and the additional restrictions in Chapter 74, Schedule V.

§ 71.05 RESTRICTED PARKING OF TRUCKS.

(A) No person, firm or corporation shall cause a commercial or freight-carrying semi-truck or its trailer separately or a commercial or freight-carrying straight-truck longer than 24 feet to be parked on any street in the city from 10:00 p.m. to 6:00 a.m., or more than 2 hours during any other time.

(B) (1) There shall be no parking of any motor vehicle, automobile, truck, semi-truck and/or trailer with the engine, refrigeration unit or other motor running, or with livestock or fowl or any other cargo which makes a noise so as to substantially annoy, injure or danger the comfort, health, repose or safety of the public or any person in the city.

(2) No person, firm or corporation shall cause a tandem axle trailer, 15 feet or greater in length, to be parked on any street in the city from 10:00 p.m. to 6:00 a.m. or greater than 2 hours during any other time. The exception to this is that parking shall be allowed if previously approved by the City Police Department.

(C) Anyone in violation of the terms of this section shall be issued a citation reflecting a forfeiture of \$25 plus court costs.

ENFORCEMENT

§ 71.15 DISABLED PARKING ENFORCEMENT ASSISTANCE COUNCIL.

For the purpose of enforcement of disability parking restrictions for the city, the city hereby authorizes the establishment of the Disabled Parking Enforcement Assistance Council as outlined under Wis. Stats. § 349.145. This statute provides that members appointed to the Disabled Parking Enforcement Assistance Council may report violations of Wis. Stats. §§ 341.625(1), 343.52, 346.503, and 346.505(2) or ordinances in conformity therewith to a traffic officer of the political subdivision in which the violation occurred, as provided in Wis. Stats. §§ 341.625, 343.52(3), 346.503(5), 346.505(3). (Ord. 548, passed 1-2-1996)

§ 71.16 PARKING FOR PERSONS WITH DISABILITIES.

Pursuant to the federal Americans With Disabilities Act, the parking areas set forth in Chapter 74, Schedule IV are hereby designated as reserved parking for those persons with disabilities, as defined by the Americans With Disabilities Act.

GENERAL PROVISIONS

§ 72.001 ROLLERSKATING, ROLLERBLADING, SKATEBOARDING AND BICYCLING.

(A) There shall be no bikeriding, rollerskating, skateboarding or rollerblading on the sidewalks in the downtown area of the city, from the intersection of High Street with Iowa Street, going east to the intersection of High Street with Commerce Street. Bicycles can be walked on the sidewalks.

(B) On all other streets within the city, bicycles may be on the streets and sidewalks. Skateboarding, rollerskating and rollerblading shall only be allowed on the sidewalks, except while crossing a roadway at a crosswalk.

BICYCLES

§ 72.015 LICENSE REQUIRED.

(A) No bicycle shall be operated upon the public streets, highways, alleys or other public property in the city until it has been licensed. The fee for this license shall be \$1. The license shall be valid for 1 year and be issued by the Police Department. A license may be refused for a bicycle not equipped with a bell, horn or other warning device, and brakes in good operating condition.

(B) Every licensee shall register his or her name, address, the name of the manufacturer of his or her bicycle, the number, style and general description with the Chief of Police. The Chief of Police shall provide and keep at police headquarters a suitable record of registration under this section, and shall provide suitable metallic identification plates which the owner shall affix and keep affixed to his or her bicycle, and shall keep the plate clean and visible at all times. License plates shall not be transferred from one bicycle to another unless a license shall be obtained for the second bicycle, and the transfer is authorized.

§ 72.016 LAMPS AND OTHER EQUIPMENT.

No person shall operate a bicycle upon a highway, bicycle lane or bicycle way after dark unless the bicycle is equipped with, or the operator is wearing, a lamp emitting a white light visible from a distance of at least 500 feet to the front of the bicycle. The bicycle shall also be equipped with a red reflector that has a diameter of at least 2 inches of surface area on the rear so mounted and maintained as to be visible from all distances from 50 to 500 feet to the rear when directly in front of lawful upper beams of headlamps on a motor vehicle. A lamp emitting a red light visible from a distance of 500 feet to the rear may be used in addition to, but not in lieu of, the red reflector.

§ 72.017 COMPLIANCE WITH RULES OF THE ROAD.

An operator of a bicycle shall observe and be subject to all regulations that are imposed upon other vehicles to the extent that such regulations are applicable and are not in conflict with this section, including the following:

(A) An operator of a bicycle shall give the proper traffic signals before making a turn or stopping, and shall obey traffic signals and warnings. The operator shall stop at all stop streets; shall keep in the proper traffic lane; shall not ride more than 2 abreast and when meeting or passing vehicles shall ride single file. The operator shall make use of the horn or bell upon his or her bicycle when overtaking pedestrians on sidewalks.

(B) An operator of a bicycle shall stop and yield the right-of-way to pedestrians at intersections. The operator shall observe all parking regulations applicable to motor vehicles, except that bicycles may be parked on sidewalks in areas where there is no adjacent space available therefor, but only if they do not interfere with pedestrian use of the sidewalks. The operator of the bicycle shall stop when emerging from a driveway or alley; shall pull as close to the curb as possible and stop when emergency vehicles such as fire trucks and ambulances approach.

(C) No operator of a bicycle shall pass another vehicle unless the road ahead within safe passing distance is visible and free of oncoming traffic; nor pass on any hill or curve; nor follow any emergency vehicle; nor race or indulge in trick or hazardous riding on any street, alley or highway. Not more than 1 person shall ride on any bicycle other than a tandem bicycle, and no person shall ride any bicycle which is in any way attached to any other moving vehicle, or while the person himself or herself is in any way attached to any other moving vehicle.

§ 72.019 OPERATION ON SIDEWALKS.

Every person riding a bicycle on a sidewalk in any place in the city shall yield the right-of-way to any pedestrian lawfully using the sidewalk.

§ 72.020 CANCELLATION OR SUSPENSION OF LICENSE.

The license granted may be cancelled or suspended at any time for cause by the Police Department. Any bicycle, upon suspension of license, shall not thereafter be used on the public street until re-registration at the expiration of the last registration or upon the suspension being removed by the Police Department. Appeal from any suspension hereunder may be taken to the Common Council.

TRAIL REGULATIONS FOR SNOWMOBILE, ALL-TERRAIN VEHICLE, MOTORCYCLE AND NONLICENSED MOTORIZED EQUIPMENT

§ 72.030 APPLICATION.

(A) This subchapter shall control the use of the Cheese County Recreation Trail and more specifically that part of the trail within the city, hereinafter "the trail," within the city, developed and administered by the Tr-County Trail Commission for use by snowmobiles, all-terrain vehicles, motorcycles, horses, bicycles, skiers and pedestrians.

(B) This subchapter shall also control the use of ***NONLICENSED MOTORIZED EQUIPMENT*** as defined to include dirt bikes, mopeds, golf carts, 4- and 6-wheeled nonregistered motorized vehicles, and go-carts.

(C) ***GO-CARTS*** are defined as follows:

(1) No homemade or reconstructed vehicles. Motorized vehicles in this category must be the original from the manufacturer with no equipment altered. This includes no modifications to suspension, axles or chassis.

(2) Vehicles must have a roll bar covered with bright yellow or orange padding.

(3) Vehicles must have a head light and tail light attached to the top of the roll bar operating at all times.

(4) Vehicles must have a ground-to-floor clearance of at least 9 inches.

(5) Vehicles must have an orange flag attached.

(6) Vehicles must have knob type tires. (Ord. 578, passed 9-2-1997)

§ 72.031 CLOSED SEASONS.

No person shall operate an all-terrain vehicle, motorcycle or unlicensed motorized equipment on the trail during such time as the trail is snow-covered, in whole or in part, or at such other times as designated or posted as a closed season by the Tr-County Trail Commission.

§ 72.032 CLOSED HOURS.

(A) The trails shall be closed to all persons during the hours of 1:00 a.m. to 5:00 a.m. (Am. Ord. 666, passed 12-7-2004)

(B) Any person violating the provision of this subchapter for a third time within a 12-month period shall, in addition to penalties and forfeiture provided in this subchapter, be prohibited from using the trail for a period of 12 months from the date of conviction of that third offense.

§ 72.033 TRI-COUNTY TRAIL STICKER OR STATE REGISTRATION REQUIRED AND SNOWMOBILE REGISTRATION.

No person shall operate licensed or nonlicensed motorized equipment on the trail without having a valid and current Tri-County Trail Commission sticker or operate a snowmobile or all-terrain vehicle without a valid and current state registration sticker displayed upon the vehicle without regard to age of the operator. Horseback riders and bicyclists 18 years or older shall also be required to have a Tri-County Trail Commission sticker.

§ 72.034 MANDATORY REPORTING OF INJURIES.

The reporting of all injuries required by law for all-terrain vehicles and licensed motorcycles shall apply to all operators of motorized equipment, used on the trail, whether licensed or unlicensed. (Ord. 578, passed 9-2-1997)

§ 72.035 OPERATION BY YOUTHFUL OPERATORS RESTRICTED.

(A) *Definitions.* For the purpose of this subchapter, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

ACCOMPANIED. Being subject to continuous verbal direction or control while operating all-terrain vehicles as defined in Wis. Stats. § 23.33(1)(a).

ACCOMPANIED for purposes of snowmobile operation. Being on the same snowmobile as the operator.

(B) *ATV operator under 12.* No person shall operate an all-terrain vehicle on the trail under the age of 12 years unless accompanied within voice contact by a parent, guardian or person over 18 years of age as set forth in Wis. Stats. § 23.33(5).

(C) *Motorcycle operator under 12.* No person shall operate a motorcycle on the trail under the age of 12 years unless accompanied within voice contact by a parent, guardian or person over 18 years of age.

(D) *Snowmobile operator under 12.* No person under the age of 12 years may operate a snowmobile unless he or she is accompanied either by a parent or guardian or by a person over 18 years of age.

(E) *Twelve- to 16-year old ATV or snowmobile operator.* No person who is at least 12 years of age but under 16 years of age shall operate, unaccompanied, an all-terrain vehicle or snowmobile on the trail, unless he or she has completed a safety certification course as provided in Wis. Stats. § 23.33(5)(b) (All-terrain Vehicles) and § 350.02(2) (Snowmobiles), and has the certification in his or her possession.

(F) *Display of safety certificate required.* No person operating an all-terrain vehicle or snowmobile or motorcycle may refuse to display his or her safety certificate after being requested to do so by a law enforcement officer or trail coordinator.

(G) *Twelve- to 16-year old motorcycle operator.* No person who is at least 12 years of age but under 16 years of age shall operate, unaccompanied, a motorcycle on the trail unless he or she has completed a safety certification course as provided in Wis. Stats. § 23.33(5)(b).

(H) *Protective head gear.* Any person under the age of 18, either operating or riding as a passenger on nonlicensed motorized equipment, motorcycles, all-terrain vehicles or snowmobiles, shall be required to wear protective headgear.

§ 72.036 NOISE AND AIR POLLUTION RESTRICTIONS.

§ 72.043 OPERATION OF AUTOMOBILE OR TRUCK ON TRAIL.

§ 72.044 TRAIL SIGNS.

(A) No persons shall erect, remove, obscure or deface any trail sign unless authorized by the Commission or its agents.

(B) No person shall operate any all-terrain vehicle, motorcycle, snowmobile or nonlicensed motorized equipment contrary to authorized posted signs. (Ord. 578, passed 9-2-1997) Penalty, see § 72.999

§ 72.048 NONMOTORIZED AND UNLICENSED MOTORIZED EQUIPMENT TRAIL USE REGULATIONS.

§ 72.052 VIOLATIONS, JUDGMENTS AND RESTITUTION.

Upon default in payment of the prescribed forfeiture, plus all applicable court costs and restitution, the Iowa County Circuit Court shall follow the procedures set forth in Wis. Stats. § 800.095, including imprisonment in the County Jail for a period not to exceed 90 days, performance of community service work or suspension of that person's Wisconsin operating privileges as set forth in Wis. Stats. § 800.095(4)(b).

(C) If the Circuit Court finds that the violation involves an ordinance that prohibits conduct that is the same as or similar to conduct prohibited by state statute punishable by fine or imprisonment or both, and further finds that the violation resulted in damage to the property or physical injury to a person other than the alleged violator, the Circuit Court may order restitution to be paid by the violator as part of the judgment pursuant to Wis. Stats. § 800.093.

(B) Other uniform citations adopted by the State of Wisconsin for the use of cities and other municipalities may be used in the prosecution of violations under this subchapter.

§ 72.072 PERMITTING OPERATION BY IMPROPER PERSONS PROHIBITED.

(A) *General.* It shall be unlawful to operate any snowmobile for off-highway use on private property or on the city streets, alleys, parks, parking lots or any other public lands or private lands or parking lots held open to the public, except for those areas designated as snowmobile trails.

(B) *Exceptions.* Snowmobiles may be operated on designated and marked snowmobile trails and, for the purpose of traveling between the operator's residence and a designated and marked snowmobile trail, and for the purpose of obtaining fuel for the snowmobile, only on streets designated and marked by the Tri-County Trail Commission, subject to the review and approval of the Chief of Police, using a curbline or shoulder of the street, excluding High Street, at a speed not to exceed 10 miles per hour.

(C) *Hours.* No person shall operate a snowmobile anywhere within the city between the hours of 2:00 a.m. until 6:00 a.m.

ALL-TERRAIN VEHICLES

§ 72.085 ALL-TERRAIN VEHICLES AND UTILITY TERRAIN VEHICLES AND ROUTES

(A) **PURPOSE.** The purpose of this ordinance is to establish all-terrain vehicle (ATV) routes in the City and to provide safe and enjoyable ATV/UTV recreation consistent with public rights and interests pursuant to Wis. Stat. §23.33.

(B) **APPLICABILITY AND ENFORCEMENT; DESIGNATION OF ROUTES.**

(1) The provisions of this ordinance shall apply as described below:

Traffic Schedules

- (a) Under Wis. Stat. sec. 23.33(8)(b), the City designates all City-maintained roads and streets as ATV routes except any road or street that is signed to prohibit ATV/UTV use.
 - (b) Under Wis. Stat. sec. 23.33(11)(am)4., the City authorizes the operation of ATVs on any county or state highway within the City territorial boundaries that has a speed limit of 35 mph or less.
 - (c) Under Wis. Stat. sec. 23.33(1m)(c), utility terrain vehicles (UTVs) may be operated on all roads and streets in the City on which ATVs may be operated.
- (2) The operation of ATVs and UTVs with snow removal devices attached is permitted on any roadway, or adjacent to any roadway, if the applicable roadway speed limit is greater than 45 miles per hour, and regardless of whether the City has jurisdiction over the roadway.
- (3) The provisions of this section shall be enforced by the Mineral Point Police Department. Adoption of this ordinance shall not prohibit any law enforcement officer or DNR warden from proceeding under any other ordinance, regulation, statute, law or order that pertains to the subject matter addressed under this section.
- (C) **RULES OF OPERATION.** The following rules of operation apply on all routes:
- (1) Speed. No ATV/UTV shall be operated at a speed greater than the speed limit on any road.
 - (2) Lights. No ATV/UTV may be operated on the routes without fully functional headlights, tail-lights, and brake lights. Every ATV/UTV being operated on the routes must display a lighted headlamp and tail lamp at all times.
 - (3) Roadway Travel. On any ATV route, all ATV/UTV operation is authorized only for the extreme right side of the roadway except that left turns may be made from any part of the roadway which is safe given prevailing conditions. All ATVs and UTVs must operate in single file. Operation on paved shoulders intended for bicycle or pedestrians, gravel shoulders, grassy in-slope, ditches or other highway right-of-way is prohibited.
 - (4) Hours of Operation. City ATV/UTV routes shall be open each day between the hours of 6:00 a.m. and 11:00 p.m.
 - (5) Operation. ATV/UTV operation on the routes shall be in accordance with the provisions of the Wisconsin State Statutes, the Wisconsin Administrative Code and all other applicable ordinances, as the same may be amended from time to time.
 - (6) Open Intoxicants. No person may possess on his or her person or in or on an ATV or UTV upon any route, any bottle or receptacle containing alcohol beverages if the bottle

or receptacle has been opened, the seal has been broken or the contents of the bottle or receptacle have been partially removed or released.

- (7) Route Closure. The City of Mineral Point may close ATV/UTV routes due to road emergencies including but not limited to blizzards or flooding or other safety hazards.
- (8) Operation in City Parks Prohibited. No person, other than an employee of the City during the course of his or her employment, may operate an ATV or UTV in any City park except on paved roads without the written consent of the City.
- (9) Operation on Sidewalks and Pedestrian Ways Prohibited. No person may operate an ATV or UTV on any sidewalk or pedestrian way.
- (10) Driver's License Required. A valid driver's license is required for operation of an ATV or UTV on the routes. Operators must be at least 16 years of age.
- (11) Insurance Required. Operators must carry liability insurance.

(D) ROUTE SIGNS.

- (1) The City will install signs on each highway that crosses its territorial boundary in a position to be viewed by motorists as they enter the City that alerts motorists that all highways under the jurisdiction of the City have been designated as all-terrain vehicle routes. Signs shall conform to the requirements of Wisconsin law, the Manual on Uniform Traffic Control Devices, the Wisconsin Department of Transportation and the Wisconsin Department of Natural Resources, at locations required under this ordinance as designated by the Common Council or its authorized representative.
- (2) No person may erect, remove, obscure, or deface any official designated route sign unless authorized by the Common Council.

(E) PENALTIES.

- (1) The penalties under Wis. Stat. §23.33(13) are adopted by reference. Deposits for violations shall be required in accordance with the Revised Uniform State Traffic Deposit Schedule, as the same may be amended from time to time.
- (2) Juvenile penalties shall be as permitted under Wis. Stat. §938.17. Deposits for violations shall be required in accordance with the Revised Uniform State Traffic Deposit Schedule, as the same may be amended from time to time and as the same may apply to juveniles.
- (3) The penalty for any violation of this ordinance for which no statutory penalty is provided shall be \$35.00 together with court costs, fees and assessments.

- (F) **SEVERABILITY.** If any provision of this ordinance or its application to any person or circumstance is held invalid, the invalidity does not affect other provision or application of this ordinance that can be given effect without the invalid provision or application, and to this end, the provision of this ordinance are severable.

- (G) **COPIES TO BE DISTRIBUTED TO LAW ENFORCEMENT.** The City Clerk shall immediately send a copy of this ordinance to the Department of Natural Resources, to the state traffic patrol, and to the Iowa County Sheriff's Department.
- (H) **SUNSET.** This ordinance shall remain in full force and effect through September 15, 2020, and shall be of no further force and effect thereafter.
